CROSS CONNECTION PROGRAM

HWPUD's cross connection staff has been methodically sending questionnaires to customers throughout the District. Folks have been asking why. Our Backflow Prevention and Cross-Connection Control Ordinance 2019-01 states "Pursuant to Chapter 333, Division 61 of Oregon Administrative Rule, it is the responsibility of HWPUD to protect its drinking water by installing and enforcing a cross connection program." If there is any possibility that the potable water supplied by HWPUD would be subjected to contamination or pollution from the service connection, an approved backflow prevention assembly would be required. Our feeling is that the property owner would best know what's going on, on their property. That is why we are sending the guestionnaires out. We appreciate the responses we have received. It is taking about one and a half months to get through one section. Don't worry if you haven't received a questionnaire yet. The answers on the questionnaire determine whether we need to do at survey at the property.

BACKFLOW TESTER ON STAFF

Last year there was one public licensed tester in the Florence area.



The Board of Directors determined that backflow testing is a priority and they support the program. Lead Water Operator Jeremy Moore went to a week-long class in the Portland area to learn the process of backflow testing. The testing equipment has been purchased by the District. Jeremy did his first testing at the beginning of March. If you currently have a backflow device, when we send you the notice to get your device tested,

there will be two names on the tester list. Both testers are trained and certified by the State of Oregon.

Cross Connection Program

A cross connection control program should comply with the regulatory requirements stipulated by the Oregon Health Authority. HWPUD should follow the "standards of the water industry" for the application of backflow prevention by:

The installation of approved backflow prevention assemblies, with the approval of assemblies being based on regulations and industry standards.

The installation of air gaps, backflow prevention assemblies and devices in accordance with industry standards.

The testing of backflow assemblies according to an approved and recognized procedure and at a frequency stipulated in regulations and recommended by industry standards.

The testing of backflow assemblies by certified testers, where the certification establishes a minimum level of training and competence of the personnel testing assemblies.

Isolation of premises by the installation of a backflow assembly on the customer's water service.

Procedures for investigating backflow incidents and restoring water quality.

Entering into a written contract with the customer to provide water service.

A comprehensive recordkeeping program.
