a. Workers' Comp – John Murphey explained that HWPUD has \$3M coverage that also covers volunteers. The rate the District pays is 33% less than if SAIF

- were the carrier. Chris Hill explained what Resolution 2014-06 meant by holding the District legally liable for claims, even if they leave the SDIS pool.
- b. Water Curtailment Ordinance 2015-01 After studying the Curtailment Ordinance, Director Todd suggested that the ordinance be written more precisely so that no one would be confused about the meaning or the enforcement procedures. Staff will revise this document and will send this out to the Directors well before a future board meeting.
- c. Email security Vickie presented some information from Orcotech concerning the warnings that Directors receive when they try to access their District email from home. There is a Security certificate that is available for \$210 per year. President Rohner asked about the tablet discussion from the previous board meeting. GM Neville will get a formal quote from Orcotech.

# 9. NEW BUSINESS

a. Employee Education – President Rohner asked GM Neville to share the District's practice of paying for classes when employees take classes to upgrade their certificates. Personnel Policy Section 10 states "Reimbursement for college-level course work will be made only if the employee receives a passing grade."
