4. APPROVAL OF MINUTES

ACTION: Director Whiteside made a motion to accept the minutes of the HWPUD Board of Directors' meeting of May 21, 2019 as presented. Director Todd seconded the motion. Directors Coviello, Rohner, Todd, and Whiteside voted aye. There were no nay votes.
