## **Heceta Water People's Utility District Resolution 2021-05**

## A RESOLUTION ESTABLISHING A METHODOLOGY TO ANNUALLY ADJUST SYSTEM DEVELOPMENT CHARGES FOR INFLATION

WHEREAS, Heceta Water People's Utility District (PUD) is an Oregon special district formed under ORS Chapter 198 and existing and exercising legal authority under ORS Chapter 261; and,

WHEREAS, the PUD is governed by an elected board of Directors; and the Board of Directors want to maintain fiscal responsibility in repairing and preplacing aging infrastructure; and

WHEREAS, 223.297 ORS 223.297 to 223.314 provides a uniform framework for the imposition of system development charges by local governments, to provide equitable funding for orderly growth and development in Oregon's communities; and,

WHEREAS, ORS 223.304(8)(b) authorizes changes in the amount of a reimbursement fee or an improvement fee is not without imposing the procedural requirements applicable to a "modification" of the SDC methodology if the change in the amount is based on the periodic application of one or more specific cost indexes or other periodic data sources and incorporated as part of the established methodology or identified and adopted in a separate ordinance, resolution, or order; and,

WHEREAS, the Board of Directors has determined the most appropriate cost index for use in annually adjusting water SDCs is the Engineering New Record's (ENR) 20 city average Construction Cost Index (CCI); where the CCI is defined by ENR as:

200 hours of common labor at the 20-city average of common labor rates, plus 25 cwt of standard structural steel shapes at the mill price prior to 1996 and the fabricated 20-city price from 1996, plus 1.128 tons of Portland cement at the 20-city price, plus 1,088 board ft. of 2 x 4 lumber at the 20-city price.

WHEREAS, it is the desire and resolve of the Board of Directors to keep its schedule of SDCs current, consistent, and adequate to support the funding of critical municipal infrastructure improvements; and,

WHEREAS, the Board of Directors has determined the cost indexing methodology hereinafter specified and established is just, reasonable, and necessary.

THEREFORE, IT IS RESOLVED: the Board of Directors hereby adopts effective August 1, 2021.

Section 1: The methodology established via Resolution 2021-02 remains adopted and in effect unchanged.

Section 2: Policy. The Board of Directors hereby establishes a policy of reviewing its water SDCs every five years.

Section 3: Between the review dates, the PUD shall apply a cost adjustment index to adjust the SDCs annually to reflect changes in costs for land, materials, labor, and construction. The specific cost index to be used, and how the index is to be applied is as follows:

- Notwithstanding any other provision, the dollar amounts of the SDC set forth in the SDC methodology report(s) shall on July 1<sup>st</sup> of each year be adjusted to account for changes in the costs of acquiring and constructing facilities. The adjustment factor shall be based on:
  - a. The annual change in construction costs according to the ENR 20 City Average CCI published in the ENR in December of each year.
  - b. The SDCs adjustment factor shall be used to adjust the SDCs, unless they are otherwise adjusted by the PUD based on a change in the costs of materials, labor, or real property; or adoption of an updated methodology.

## Billing:

Billing shall be on a monthly basis and payment is due by the 25th of the month for the previous period. Non-payment will be cause for termination of water service. If a meter fails to register the amount of water used for any period, the charge for that period will be calculated based on the average quality of water used in the previous billing period. Any water user may request a meter check if the water usage records appear unreasonable. If the readings appear unreasonable to the General Manager, the General Manager will assist in determining the cause of the reading.
