1. CALL TO ORDER

Director Farnsworth called the meeting of the Board of Directors of the Heceta Water People's Utility District to order at 4:00 pm on February 15, 2022.

6. FINANCIAL REPORT

Secretary of Record, Mike Buckwald stated the District's financials are good, and all budget requirements are met. Buckwald confirmed the local credit union is a qualified depositor with the State. He reported that OPB pays higher interest than any other local depository including the credit union.

He stated the project at Mercer Lake Road is complete but is still working with District Attorney Spencer to create a hold harmless with the County to come to agreement on party responsible for road paving over potholes. GM Neville anticipates bringing resolution to the Board at the next board meeting. Director Farnsworth inquired about success of County not hitting our water lines. GM Neville reported out of 3000 nails the line was hit only once. He went on to say the District located water lines accurately and part of the hold harmless is to determine if County will reimburse costs partial or all for the damaged water line. Director Whiteside asked if the crankshaft project is complete. GM Neville reported that the City hired Ray Wells to complete the project and our staff was on sight the whole time. Director Farnsworth asked how working with the City is

progressing. GM Neville stated that the District is working to enhance our relations with City staff.
